

LEGAL NOTICE OF COURT APPROVAL OF:  
**VOLKSWAGEN / AUDI 2.0L TDI (DIESEL) EMISSIONS SETTLEMENT IN CANADA**

COURTS HAVE APPROVED A NATIONWIDE SETTLEMENT IN CANADA TO BENEFIT MANY OWNERS AND LESSEES OF THE FOLLOWING 2.0L TDI VEHICLES ORIGINALLY SOLD OR LEASED IN CANADA:

<b>VW Jetta</b> 2009-2015	<b>VW Jetta Wagon</b> 2009	<b>VW Golf</b> 2010-2013, 2015	<b>VW Passat</b> 2012-2015
<b>VW Beetle</b> 2013-2015	<b>VW Golf Wagon</b> 2010-2014	<b>VW Golf Sportwagon</b> 2015	<b>Audi A3</b> 2010-2013, 2015

YOU MAY BE ELIGIBLE FOR BENEFITS IN THE SETTLEMENT IF YOU OWNED OR LEASED ONE OF THESE VEHICLES ON SEPTEMBER 18, 2015 OR CURRENTLY OWN ONE OF THESE VEHICLES

**ELIGIBLE OWNERS AND LESSEES MAY SUBMIT A CLAIM FOR BENEFITS NOW**

**If you are an eligible current owner and owned your vehicle on September 18, 2015, you may claim:**

- **Buyback** of your vehicle + **Cash** –OR–
- **Trade In** your vehicle towards the purchase of a new or used Volkswagen / Audi vehicle + **Cash** –OR–
- Keep your vehicle and receive an **Approved Emissions Modification** + **Extended Emissions Warranty** + **Cash**

**If you are an eligible current owner and purchased your vehicle after September 18, 2015, you may claim:**

- Keep your vehicle and receive an **Approved Emissions Modification** + **Extended Emissions Warranty** + **Cash**

**If you are an eligible lessee and continue to be in your lease, you may claim:**

- **Lease Termination** with no early termination penalty + **Cash** –OR–
- Keep your vehicle and receive an **Approved Emissions Modification** + **Extended Emissions Warranty** + **Cash**

**If you are an eligible owner or lessee and no longer have your vehicle, you may claim **Cash****

**HOW DO I MAKE A CLAIM?**

- The period for submitting a claim begins on April 28, 2017 and runs until September 1, 2018.
- You may submit a claim online through [www.VWCanadaSettlement.ca](http://www.VWCanadaSettlement.ca).
- Alternatively, you may complete a paper claim form available at [www.VWCanadaSettlement.ca](http://www.VWCanadaSettlement.ca) or by calling the Settlement Claims Centre at 1-888-670-4773 and submit your form by mail to the address indicated on the form.

The Courts will approve amounts for legal fees and expenses to Class Counsel. Those amounts will be paid separately and will not reduce your Settlement benefits.
